4-28-69 F.B.T.D. 2390', tested casing to 4000# O. K. Perf. Pictured Cliffs 2250-54', 2262-72' w/16 SFZ. Frac w/30,000# 10/20 sand, 30,030 gal. water. Max. pr. 4000#, EDP 2000#, avg. tr. pr. 3400#, I.R. 18.3 BPM. Dropped 1 set of 16 balls, flushed w/672 gal. water. ISIP 800#, 5 Min. 700#, 15 Min. 650#, 30 Min. 600#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
