Instructions

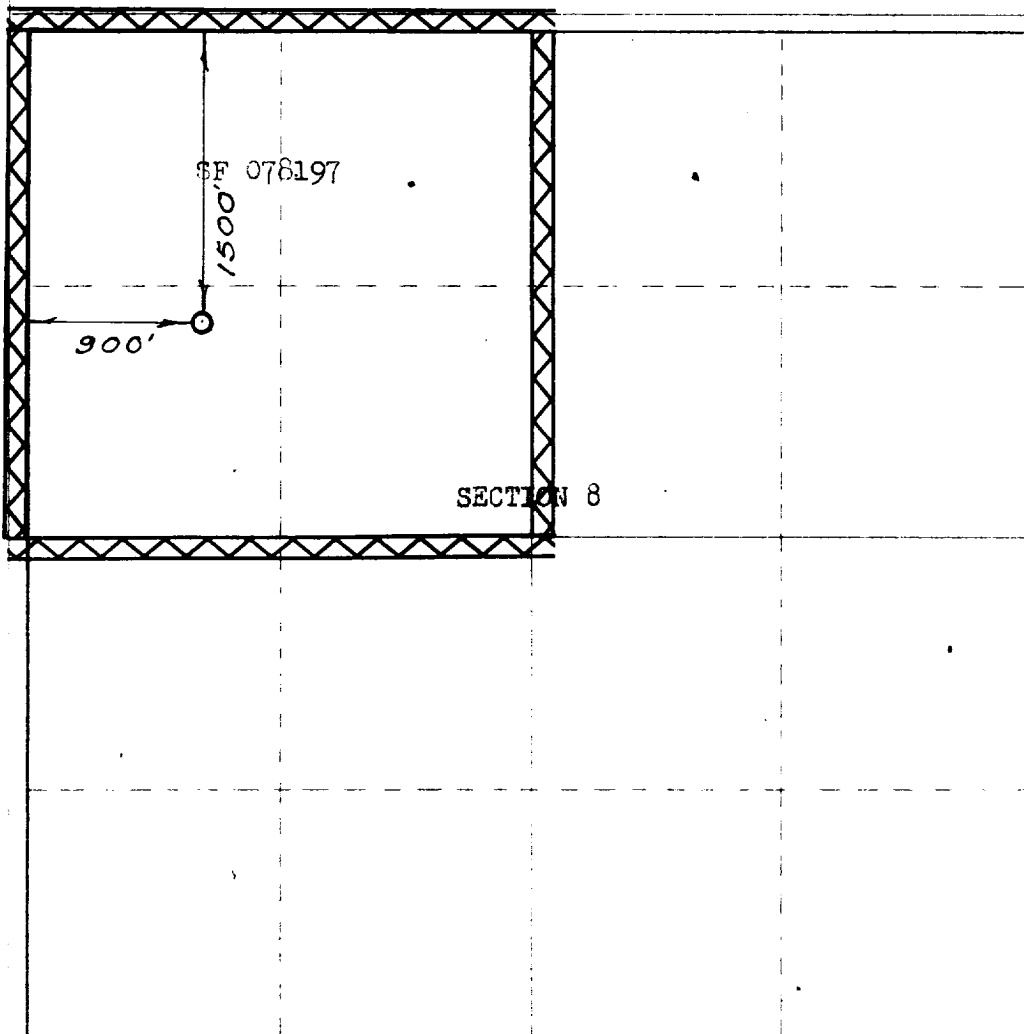
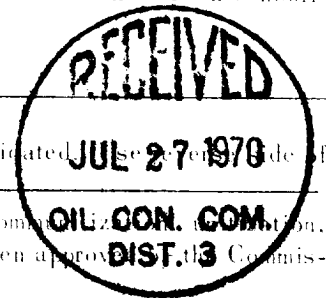
