The well will then be drilled to TD with a low solids nondispersed mud system. Completion design will be based on open hole logs. Copy of all logs will be filed upon completion. Amoco's standard blow-out prevention will be employed; see attached drawing for blowout preventer design.

Upon completion the well location will be cleaned and the reserve pit filled and leveled.

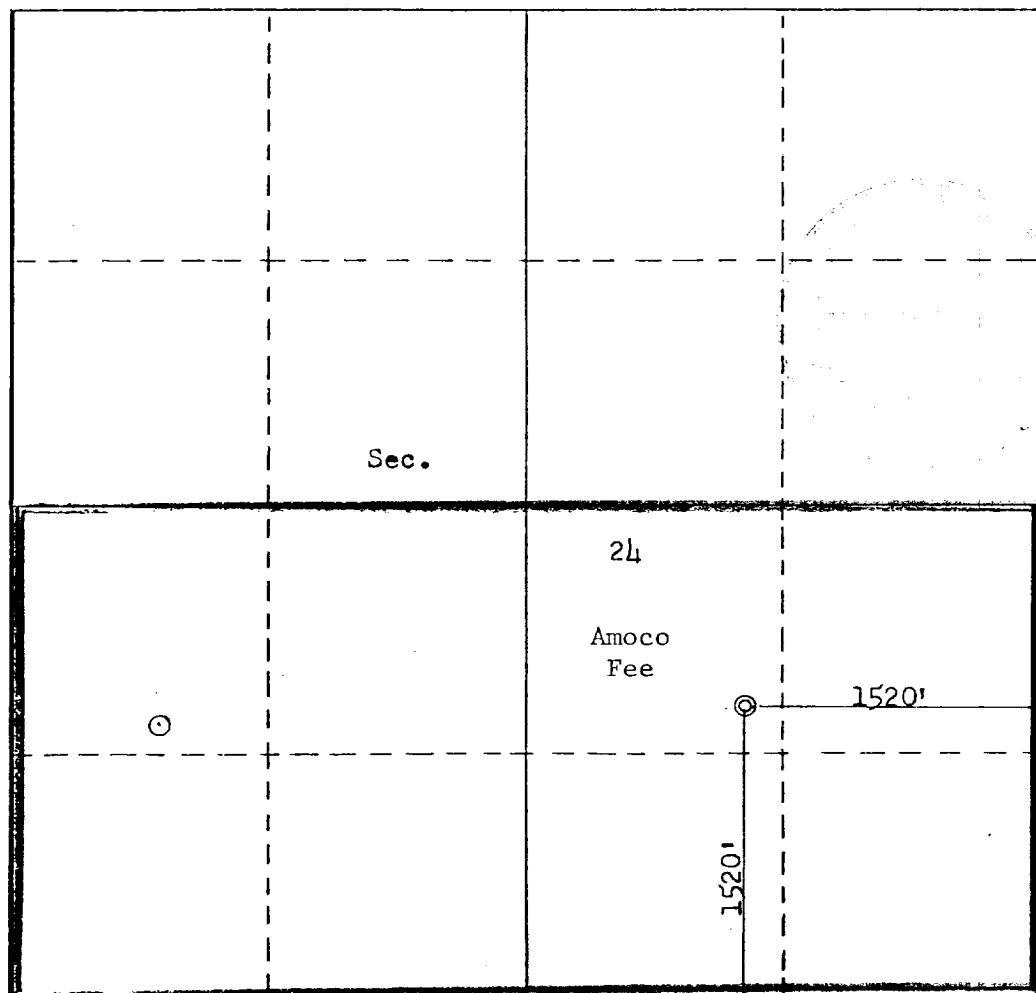

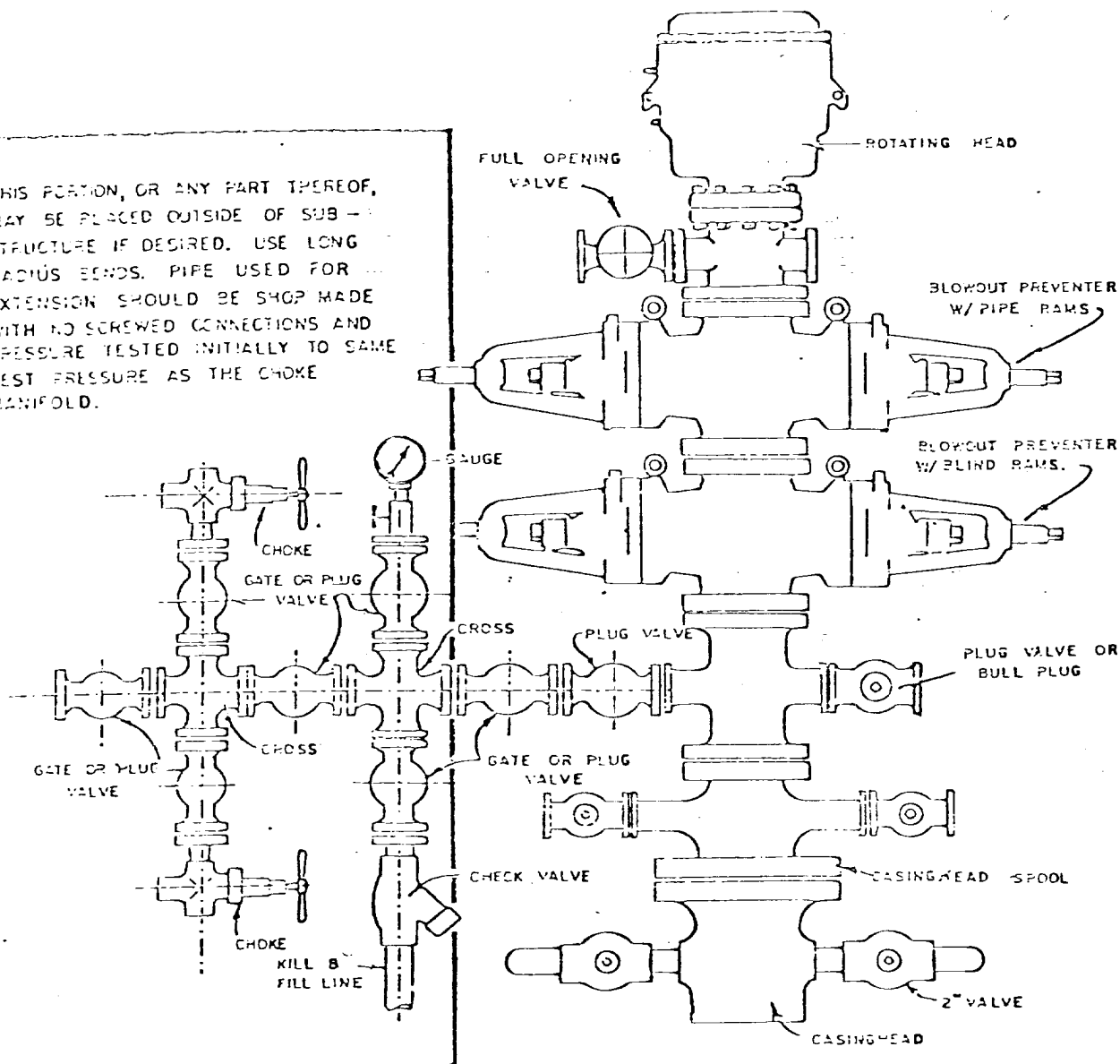
