Our current plan is to try to place the Maxey No. 1-J on compression as soon as possible to evaluate the Pictured Cliffs potential. Depending on the results of this test, we will either re-work or plug and abandon the Maxey No. 1. We will continue to evaluate the Fruitland Coal formation for possible development.

Since this project has been more time consuming than we anticipated, we request on extension of time to April 30, 1995.
