2. Perforate Mesaverde with total 28 - 0.34" holes at 4256', 70', 72', 78', 80', 85', 94', 4306', 07', 08', 09', 10', 13', 14', 44', 60', 68', 93', 94', 4424', 42', 61', 68', 91', 4522', 60', 68', 4610'.
3. Acidize Mesaverde 4256'-4610' (gross) with 1700 gals 15% HCL with 56 ball sealers.
4. Frac Mesaverde 4256'-4610' (gross) with 100,000# 20/40 sand in 115,000 gals 2% KCL slick water. Set RBP at 4220'.
5. Perforate Mesaverde with total 21 - 0.34" holes at 3850', 63', 67', 69', 91', 92', 3944', 46', 4019', 25', 42', 43', 44', 46', 48', 95', 4117', 18', 19', 80', 81'.
6. Acidize Mesaverde 3850'-4181' (gross) with 550 gals 7-1/2% HCL and 1400 gals 15% HCL and 42 ball sealers.
7. Frac Mesaverde 3850'-4181' (gross) with 80,500# 20/40 sand in 91,000 gals 2% KCL slick water.
8. Jar out RBP at 4220'. Left slips imbedded in casing at 4220'. Left junk and sand on RBP at 5000'. Had trouble getting junk basket past slips at 4220'.
9. Temporarily abandon Gallup until Mesaverde is depleted.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
