11/05/01: Drilling 8 ¾" hole with mud to 1352'

11/06/01: Drilling to 2000'. PU directional tools at 2000' for kick off point.

11/07/01: Directional drilling to 2690'.

11/08/01: Directional drilling to 3024'.

11/09/01: Directional drilling to 3044'. Attempt to run 7" casing, could not get casing through bridge at 1385'.
