The log log paper used for plotting the back pressure curve shall be of at least three inch cycles.

## NOMENCLATURE

- Q I Actual rate of flow at end of flow period at W. H. working pressure ( $P_{\rm W}$ ). MCF/da. @ 15.025 psia and 60° F.
- $P_c$ = 72 hour wellhead shut-in casing (or tubing) pressure whichever is greater. psia
- Pw Static wellhead working pressure as determined at the end of flow period. (Casing if flowing thru tubing, tubing if flowing thru casing.) psia
- $P_{t}$  Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.) psia
- $P_{f}$  Meter pressure, psia.
- hw Differential meter pressure, inches water.
- Fg Gravity correction factor.
- Ft Flowing temperature correction factor.
- Fpv Supercompressability factor.
- n I Slope of back pressure curve.

Note: If  $P_w$  cannot be taken because of manner of completion or condition of well, then  $P_w$  must be calculated by adding the pressure drop due to friction within the flow string to  $P_t$ .
