A 15" hole was spudded at 12:00 midnight on August 20, 1973 and drilled to 312'. The 10-3/4" casing was set at 311' with 300 sacks Class "A" cement with 2% CaCl₂, August 21, 1973, and the cement circulated. The casing was tested to 500 psi OK. The hole was reduced to 9-7/8" at 311' and drilling resumed.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
