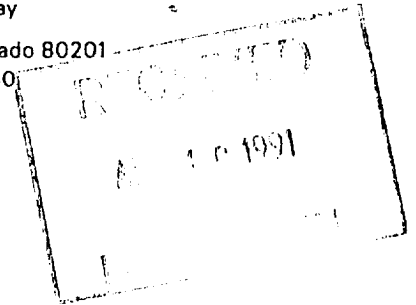

AGREEMENT AND CONVEYANCE OF INTEREST IN WELLS

KNOW ALL PERSONS BY THESE PRESENTS:

THIS Agreement is made and entered into this 15th day of August, 1990, by and between AMOCO PRODUCTION COMPANY (hereinafter referred to as "Amoco"), having an office at 1670 Broadway, Denver, Colorado 80201, and the JICARILLA APACHE TRIBE of the JICARILLA RESERVATION, New Mexico.

WHEREAS, Amoco is the owner of certain oil and gas leases, more particularly described as follows which expired by their own terms on July 27, 1988:

(a) Contract No. 525 - Jicarilla Tribal No. 525 well.

WHEREAS, in lieu of Amoco plugging and abandoning the wells drilled on the above-described lands and reclaiming the locations and in consideration for the Jicarilla Apache Tribe receiving the equipment located on the above-described premises and in said wells, the parties hereto agree as follows:

1. That Amoco agrees to relinquish, terminate and waive all right, title and interest to the oil and gas leases above described and any unitization, pooling or operating agreements entered into by Amoco, all in accordance with applicable federal laws and regulations;
2. That Amoco hereby assigns, transfers and conveys to the Jicarilla Apache Tribe all right, title and interest in, to, under, or derived from all presently existing wells and production from the above-described leases only;
3. That Amoco hereby assigns, transfers and conveys to the Jicarilla Apache Tribe all right, title and interest in and to all wells, equipment, fixtures and personal property located on the lands above described as generally described on Attachment "A" attached hereto and made a part hereof, pursuant to paragraph seven of the Leases;
4. The Jicarilla Apache Tribe shall, at its sole expense, comply with all laws, rules, regulations, orders and ordinances of any governmental authority holding jurisdiction over the wells, including, but not limited to those laws pertaining to abandonment and plugging of wells, and the restoration of the surface, the cost of which the Tribe hereby assumes;
5. That the Jicarilla Apache Tribe hereby releases Amoco from any claims, causes of action, demands or damages arising out of operations on said oil and gas leases; and
6. AMOCO MAKES NO WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, AS TO THE CAPABILITY OF THE WELLS TO PRODUCE, NOR TO THE CONDITION OF THE WELLS AND THE MATERIAL THEREIN LOCATED.

This Agreement is effective as of July 27, 1988.
