13. Describe Proposed or Completed Operations

This well was spud 9-18-90, 9 5/8" surface casing set @ 222' and cmt'd. On 9-21-90 intermediate 7" csg was set @ 3174' and cmt'd. Ten joints of 4 1/2" casing were set @ 3379'. This well was perforated 5-27-91 with perfs 3204-3337'.

Plans are to move a rig on during the third quarter of 1993 for fracture stimulation and completion of this well. The well will be tested and a completion report filed at that time.
