AMENDED REPORT

9/6/92: **Tested** Casing to 3500 psi. Held OK.

Perforated: 3390' to 3402' and 3408' to 3418' w/3 shots per foot, total of 72 holes (0.5 inch).

Acidized perforations w/250 gal 7-1/2% HCl, 2 gal 1-22, 2-1/2 gal citric acid. **Re-acidized** w/250 gal 7-1/2% HCl, 2 gal 1-22, 2-1/2 gal citric acid.

9/10/92: **Sand-Foam Fractured** w/ 25,000* 40/70 Sand & 22,100* 20/40 Sand; 95,785 gallons linear gel water; and 879140 SCF Nitrogen. Average Injection Rate = 45 barrels per minute. Average Injection Pressure = 3750 psi.

9/22 & 23/92: **Flowed** 24 hours on 1/16" choke at a stabilized rate of 127 MCFPD.

Shut down for winter.
