Loaded annulus w/95 bbls Fruitland Coal produced water containing 1 drum of Baker Tretolite CRW-37. ND BOP & NU WH. RD. rig. Bleed down gas. Pumped 10 bbls CRW-37 inhibited water & pressured up annulus to 500 psi and held 30 minutes. Good test. Released rig 10/16/00.
