Phillips' plans are to run a casing integrity test on this well by setting a packer in the hole to isolate the coal interval. We will then run tubing, inject packer inhibited fluid down the backside and pressure up on the casing and test. The packer will remain in hole for future tests. Plans are to continue using this well as a pressure observation well.

The well is located in the BLMs winter closure area, as well as the Elk calving closure area. We will do this casing integrity test after July 15, 2000. A subsequent sundry will be submitted upon completion.
