

Dear Mr. Kendrick:

Reference is made to your application on behalf of Parker and Parsley Petroleum Co. dated September 18, 1990 for a non-standard coal gas well location for the Rosa Unit Well No. 312 to be located 1490 feet from the South line and 230 feet from the West line (Unit L) of Section 28, Township 31 North, Range 4 West, NMPM, Basin Fruitland Coal (Gas) Pool, Rio Arriba County, New Mexico. The W/2 of said Section 28 shall be dedicated to the well forming a standard 320-acre gas spacing and proration unit for said pool.

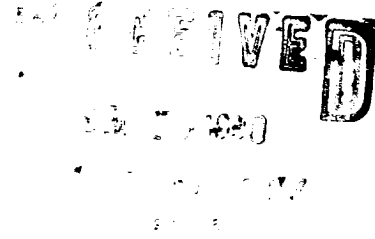

We, on behalf of Parker & Parsley Petroleum Company, hereby make application for approval of the location of the Rosa Unit #312 well to be located 1490 FSL 230' FWL of Section 28, Township 31 North, Range 4 West, Basin Fruitland Coal Gas Pool, Rio Arriba County, New Mexico.

The reason for the non-standard location is due to topographical and archaeological conditions.

An attempt was made to locate the well farther east in the edge of the timber at the base of the hill, but archaeological conditions prevent a location at that site.

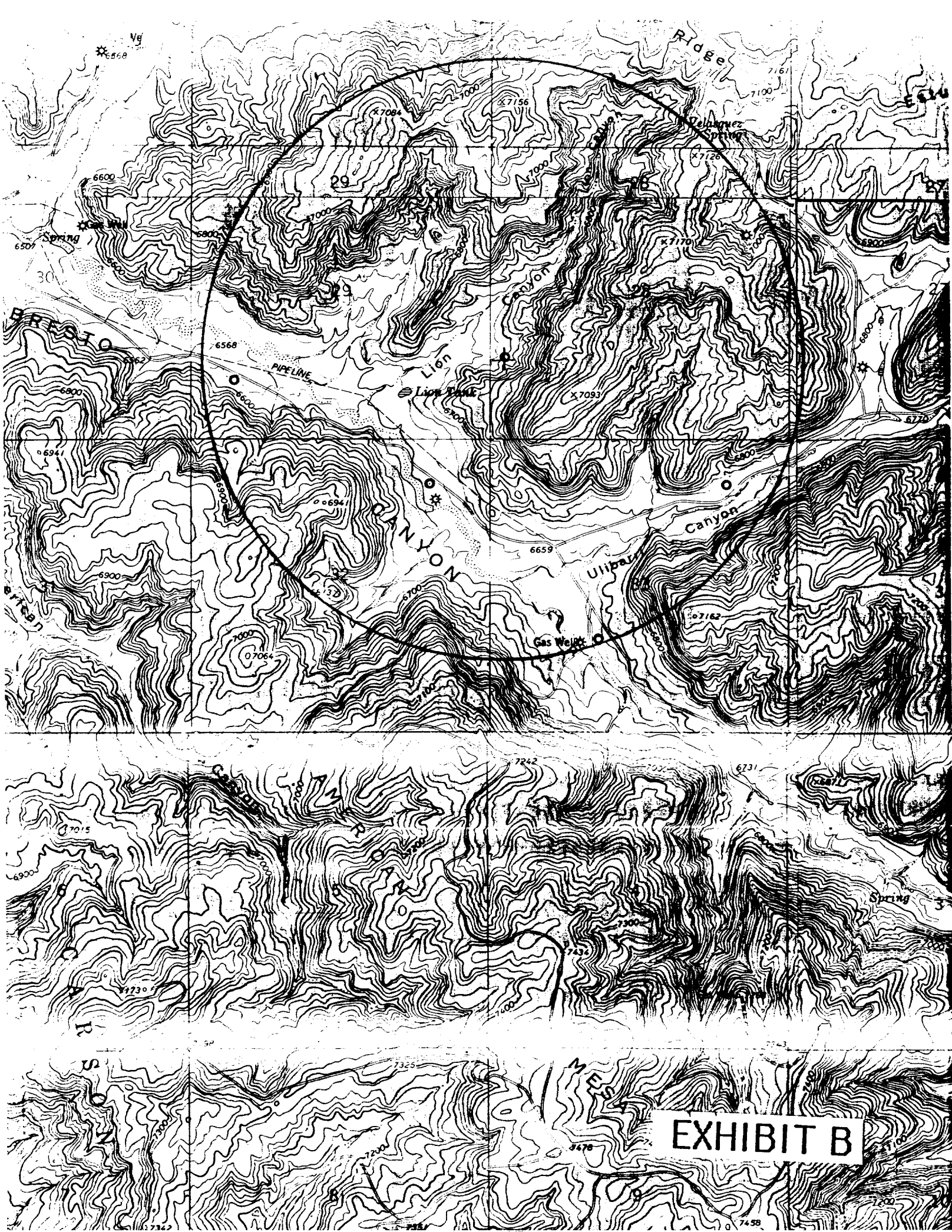

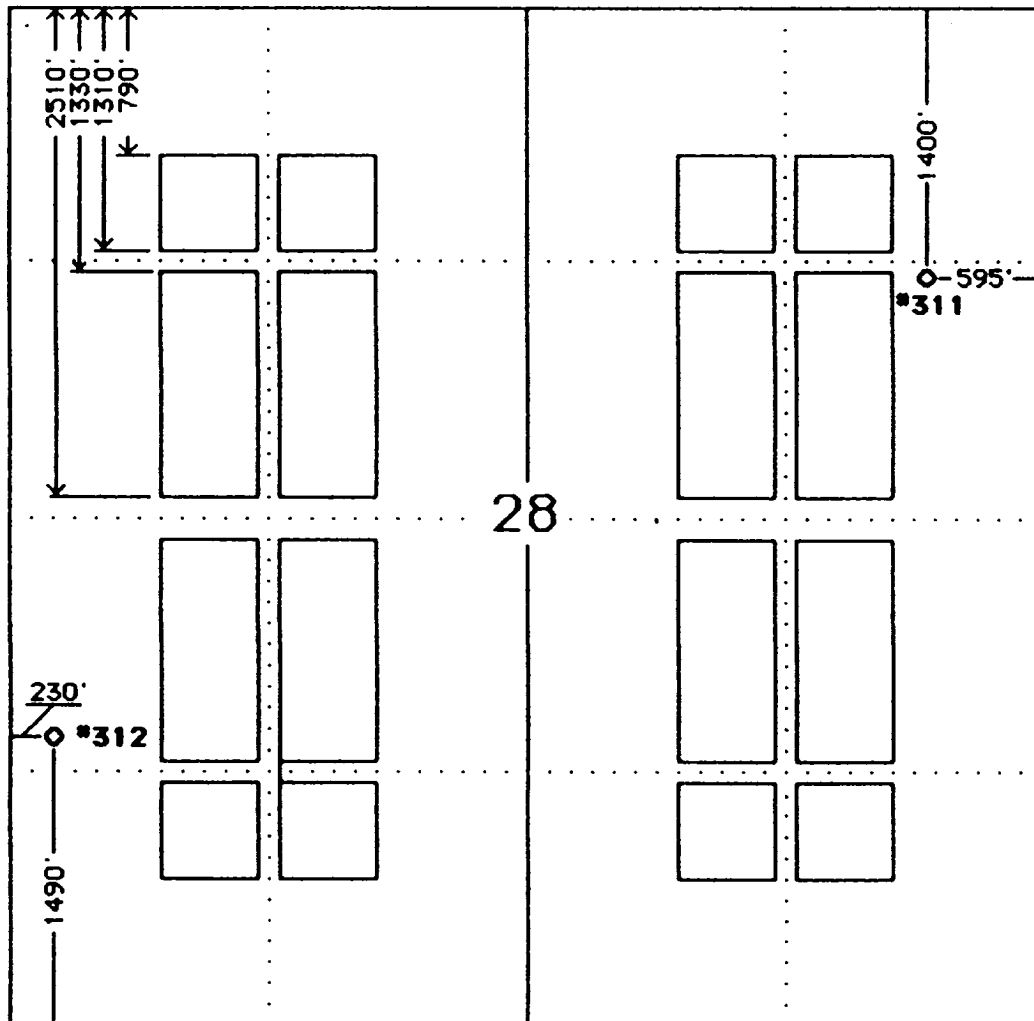

During our supervised On-Site Inspection, we found the following to exist:

The U.S. Forest Service suggested that the location be placed with as little environmental damage as possible.

This is the only area in the southwest quarter of Section 28 that is ecologically satisfactory.

We attempted to locate the well farther east between the drainages, but encountered an archaeological site which prevented the use of that area.

A location in the standard location window would be in extreme topography and the construction and maintenance costs would be excessive.

This location would cause minimal environmental damage; and, does not crowd any well inside or outside of Section 28.
