Operations were suspended for the winter due to U.S. Forest Service Regulations.

Construction of the gas gathering system was also suspended for the winter by the U.S. Forest Service. **Due** to the classification of the Mexican Spotted Owl as an endangered species, construction of portions of the gas gathering system has been delayed, beyond our control, pending a decision by the Fish and Wildlife Service.

Completion of the well will comply with the approved APD when operations are continued.

Therefore; we hereby request approval for further suspension of field operations until a chance for a return-on-investment possibility can be reasonably anticipated, or until the last day of operations authorized by the U.S. Forest Service for 1993, being **October 31, 1993**.
