Plans are to add the Mesaverde interval to the existing Dakota well and then commingle production from both zones per DHC Order R11188. The individual DHC application sundry detailing the DK forecast will be filed and approved before actual commingling occurs. Brief details of the procedure we will use are as follows:

MIRU. COOH w/production tubing. Isolate existing Dakota interval with bridge plug. Pressure test the casing and remediate with cement if casing fails pressure test. Run GR/CCL/CBL and remediate with cement if the interval completing isn't adequately covered. Perforate and stimulate the Pictured Cliffs. Remove bridge plug and return well to production with the Mesaverde and Dakota commingled. *Mesaverde.*


