

Dear Mr. Kendrick:

Reference is made to your application on behalf of the operator Evergreen Operating Corporation by letter dated September 4, 1992 for a non-standard coal gas well location for the Chicosa 34 Well No. 2 to be located 215 feet from the North line and 780 feet from the West line (Unit D) of Section 34, Township 31 North, Range 4 West, NMPM, Basin Fruitland Coal (Gas) Pool, Rio Arriba County, New Mexico. The W/2 of said Section 34 shall be dedicated to the well forming a standard 320-acre gas spacing and proration unit for said pool.

By the authority granted me under the provisions of Rule 8 of the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool as promulgated by Division Order No. R-8768, as amended, the above-described unorthodox coal gas well location is hereby approved.

Gentlemen:

We, on behalf of Evergreen Operating Corporation, hereby make application for approval of the location of the Chicosa 34 #2 well to be located 215' FNL 780' FWL of Section 34 Township 31 North, Range 4 West, Basin Fruitland Coal Gas Pool, Rio Arriba County, New Mexico.

The reason for the non-standard location is because of topography and lease restrictions set by the U.S. Forest Service to avoid further damage to the environment and wildlife habitat.

We believe that directional drilling should not be required because a beam pump and rods may be required to lift water from the wellbore to sustain production.

The attached exhibits show the situation at the location and surrounding area.

It is our belief that the information contained in this application is true and correct according to the information available to us.

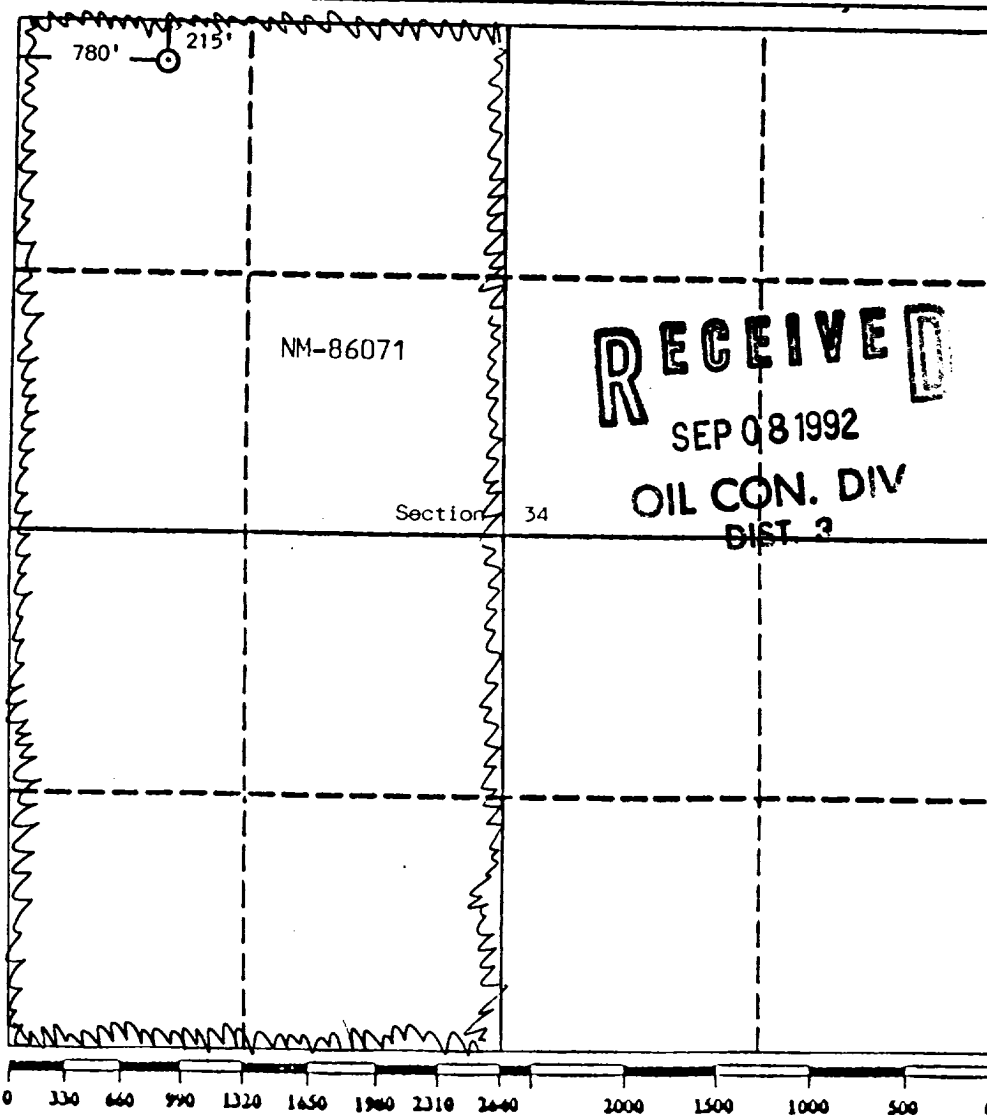

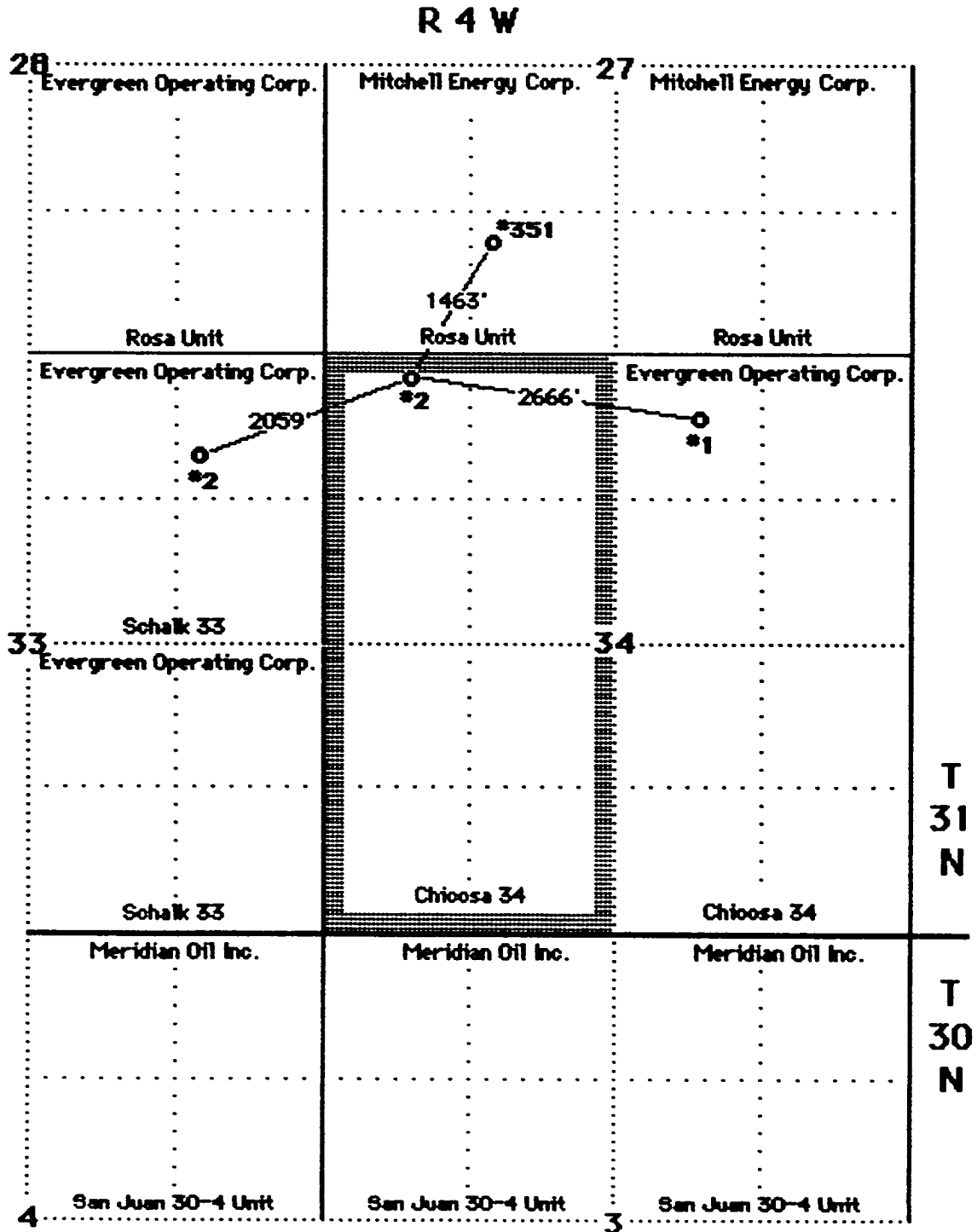

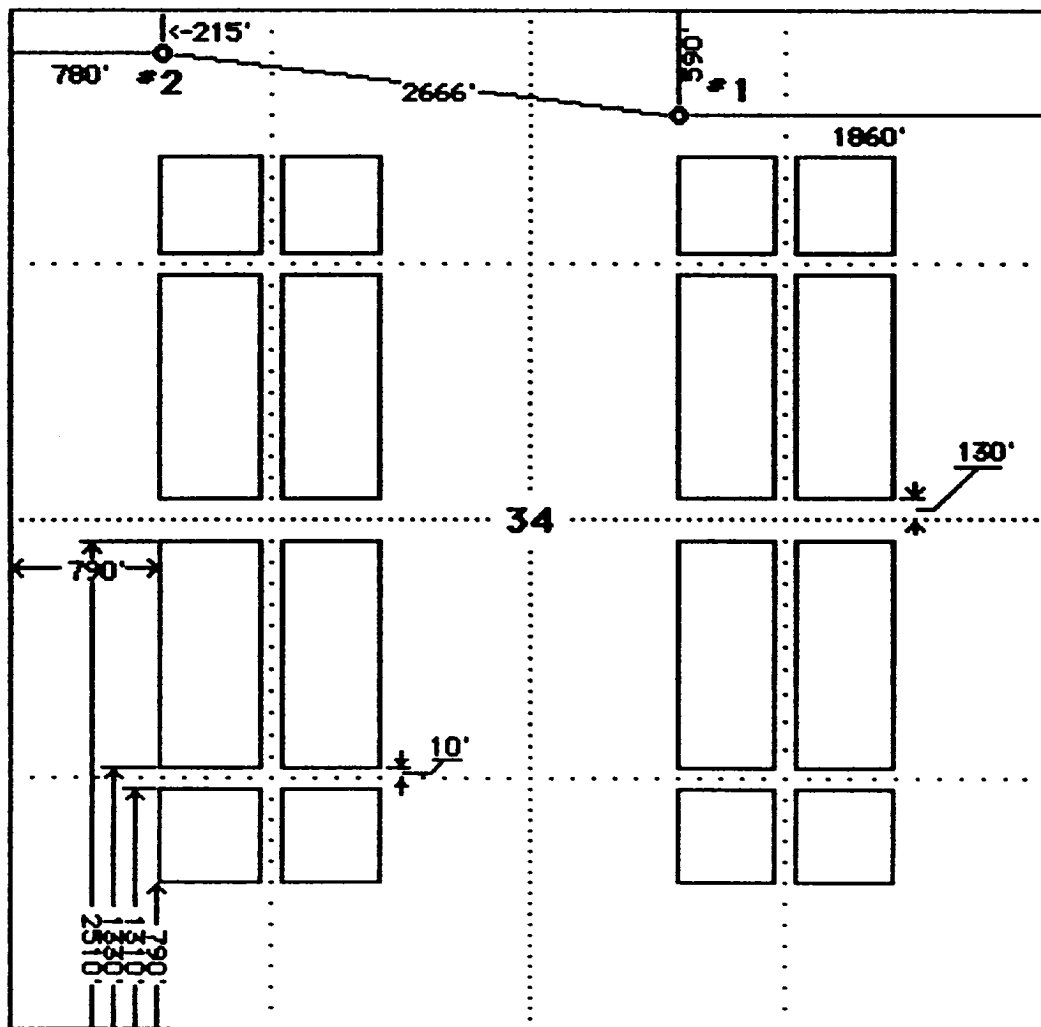

- The location was restricted by limitations in the lease set by the US Forest Service.
