The right-of-way is an existing road that crosses the NE/NE of Section 6 and the NW/NW of Section 5, T31N, R5W; S/2 of Section 32, T32N, R5W, and the N/2 NE/4 Section 5, and the SW/SW of Section 4, T31N, R5W where it joins with the main Rosa Road. The Rosa Road continues SW approximately 22 miles where it joins with the Sims Mesa Highway.


