11/19/01 MIRU Key #940. Kill well. ND WH & NU BOP. PT-OK. COOH w/tubing. RIH w/CIBP & set @ 4910'. Load hole & PT-OK. COOH. RU Blue Jet & perforated 2 squeeze holes @ 4075'. Established injection rate. RIH & set cement retainer @ 4020'. Squeezed 55 sx Type III 35:65 POZ L w/6% gel, 10#/sx CSE, 0.02#/sx Static Free, 0.75% FL-52, 0.2% CK-32, 0.25#/sx Celloflake. Tailed w/50 sx Type III w/1% CaCl2 (approx. 150% excess). Displaced w/15.6 bbls. Reversed out 1 bbl good cement. Calculated TOC now @ 3028'.

RIH w/bit & tagged cement @ 3960. D/O cement & then milled cement retainer @ 4020'. Drilled out 60' cement to CIBP @ 4910'. PT squeeze holes to 500 psi - 30 minutes. Good test. D/O CIBP @ 4910'. C/O sand on CIBP @ 6050'. D/O CIBP, then C/O fill to 7977' PBD. COOH. RIH w/2-3/8", 4.7# tubing and set @ 7932 w/"F" nipple set @ 7924'. ND BOP, NU WH. Pumped off expendable check. RD & released rig 11/29/01. Turned well over to production. MV/DK zones were put back on line as commingled on 12/1/01.
