Perforated Dakota interval @ 1spf .36" holes as follows:

8072' - 8075'; 8064' - 8067'; 8022' - 8033'; 7974' - 7990' - total 37 holes.

ND W/L. Acidized perms w/1000 gal 10% Acetic acid and ballsealers. Retrieved balls. RU to frac. Pumped 50,610 gal 60 quality N2 & 35# Borate X-link Viking Gel w/800,000 scf N2 w/4,500#s 100 mesh & 81,534# TLC 20/40 sand. Flowed back on 1/4" and 1/2" chokes. Kill well w/60 bbls 2% KCl. water. RIH cleaned out out fill to 8061'. PUH & set @ tubing @ 8049' with "F" nipple set @ 8027'. ND BOP & NU WH. PT - OK. ND BOP & WH. Pumped off expendable check. Turned well over to production to first deliver.
