Pumped 10 bbls FW, 10 bbls mud clean, and 10 bbls FW w/dye ahead of Lead - 500 sx (1190 cf - 211.93 bbl slurry) Type III, 35/65 POZ, 5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% Bentonite, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static Free. Tail - 50 sx (70 cf - 12.46 bbl slurry) Type III, 1% CaCl2, 1/4#/sx Cello-flake. Displaced w/153.5 bbls FW. Plug down 0230 hrs. 10/7/00. Circ. 15 bbls cement to surface. WOC. DN BOP, set slips and cut off casing.

NU BOP PT - OK. RIH w/6-1/4" bit to 3780' PT casing - 200 psi, then 1500 psi. Good test.
