Pumped 220 sx (310 cf - 55.20 bbl slurry) Type 3, 2% CaCl₂, 1/4#/sx Cello-flake, Displaced w/25 bbls H₂O. Plug down @ 0230 hrs 10/4/00. Had 10 bbls cement (56 cf) cement circulated to surface. WOC.

NU WH, BOP & manifold. PT to 200 psi, and then 1500 psi. Good test.

Note: The 36# J-55 casing that we permitted we'd being using on this well was not available, therefore we had to use the 32.3# H-40 casing.
