RIH w/8-3/4" bit & drilled cement to 228' and drilled ahead to 3130'. Circ. hole. RiH w/7", 20#, J-55 casing and set @ 3128'. RU to cement. Pumped a preflush of 10 bbls FW & 10 bbls mud cleand and 10 bbls FW/red dye in last 5 bbls. Then pumped Lead of 400 sx (950.6 cf - 169.3 bbl slurry) Premium Lite High S 35:65 POZ Type 3 cement w/5% gel, 0.02#/sx Static Free, 10#/sx CSE, 5#/sx LCM-1, 1/4#/sx Cello-flake, 3% CaCl₂, 0.4% FL-25.

Then pumped tail - 50 sx (70.2 cf - 12.5 bbl slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl₂. Dropped plug and displaced w/125 bbls FW. Plug down @ 2028 hrs 11/3/01. Bumped plug w/1680#. Circulated 10 bbls cement to surface. WOC. ND BOP & set slips and cut off casing. PT casing, blind rams and manifold to 200# - 3 minutes and 500# 30 minutes. Good test.
