Acidized perfs w/750 gal of 15% HCL. 8/14/02 BJ pumped 47,516 gal 25# Linear gel 60 Quality N2 foam w/100,940 # 20/40 Brown sand. Flowed back on 1/4" & 1/2" chokes. RD flowback equipment. NU WH & turned well over to production department on 8/16/02. Will have to swab to get to flow.

Plans are to test flowing up the casing. Will return within 60 days and run the tubing.
