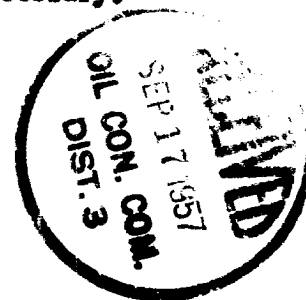
Following is a Notice of Intention to do certain work as described below at the PAN AMERICAN PETROLEUM CORPORATION

FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to workover the above well as follows:

1. Move in and rig up workover rig.
2. Clean out hole with gas to total depth, or whipstock hole, if necessary.
3. Run 5" liner to total depth & cement.
4. Drill out cement and perforate selected zones.
5. Stimulate with sand-water frac.
