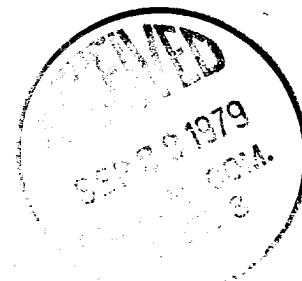

Amoco Production repaired the subject well as follows:

1. Located casing leak at 313' on back side of casing.
2. Squeezed leak with 75 sx class "B" Neat cement containing 2% Cl₂ and pumped in 25 sx cement at 500 PSI.
3. Set packer at 386' and located leak.
4. Squeezed leak with 75 sx class "B" Neat cement containing 2% CaCl₂.
5. Drilled cement out to 386' and pressure tested casing to 750 PSI, held OK.

Released rig on 9-22-79.
