## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was spudded on November 22, 1954 at 7:00 A.M., and 9-5/8" casing was landed at 276 feet with 195 sacks of cement. After waiting 34 hours on cement, water shut-off and casing were tested with 600 pounds for 30 minutes with no drop in pressure. Drilling operations were resumed.
