DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On December 1, 1954, 7" casing was landed at 4032 feet and cemented with 50 sacks cement and 50 cubic feet perlite and 6% gal followed by 50 sacks neat cement. After waiting on cement 35 hours, water shut-off and casing were tested at 600 pounds pressure for 30 minutes with no drop in pressure. Drilling operations were resumed.
