- Clean out to TD @ 1808'. Set bottom plug 1808'-1335'.
- Attempt to pull 7" casing.
- Set 100' plug at casing stub.
- Set 100' plug separating the Fruitland and Farmington Formations @ 550'-650' in and out of casing.
- Set 200' plug across Ojo Alamo formation @ 250'-450' in + out of casing.
- Set 20 sack plug at the surface.
- Set dry hole monument.
- Clean and restore location.
