DETAILS OF WORK

TD 2538'; PBD 2496' - Tested casing with 3000 psi for 30 minutes, which held with no indication of pressure drop. Made AbrasiJet Jet at 2476' with 3000-3300 psi for 30 minutes using 3750 pounds sand. Spotted 200 gallons breakdown agent. Sand-water fracked with 30,300 gallons semi-jelled water and 40,000 pounds sand. Used 300 pounds J-79 and 1500 pounds J-92. Breakdown pressure 1800 psi, average treating pressure 1600 psi, average injection rate 54 barrels per minute. Well opened up and flowed 18 hours. Preliminary gauge November 26, 1959 4295 MCFFD at end of 18 hour period. Ran 1-1/4" tubing and landed at 2463'. Completed as shut-in Blanco Pictured Cliffs Field gas well November 26, 1959.
