We propose to drill with Rotary Tools to the top of the Cliff House Sand, set pipe, then drill with rotary, using gas, if available, through Cliff House, Manosco, and Point Lockhart, shoot with nitro and clean out for gas completion in the Mesa Verde.

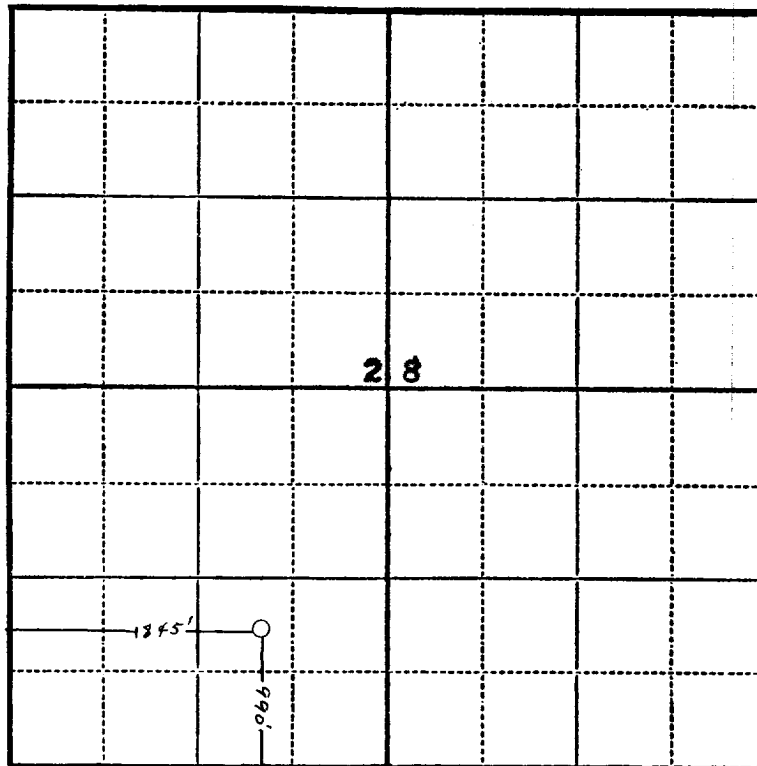
