This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

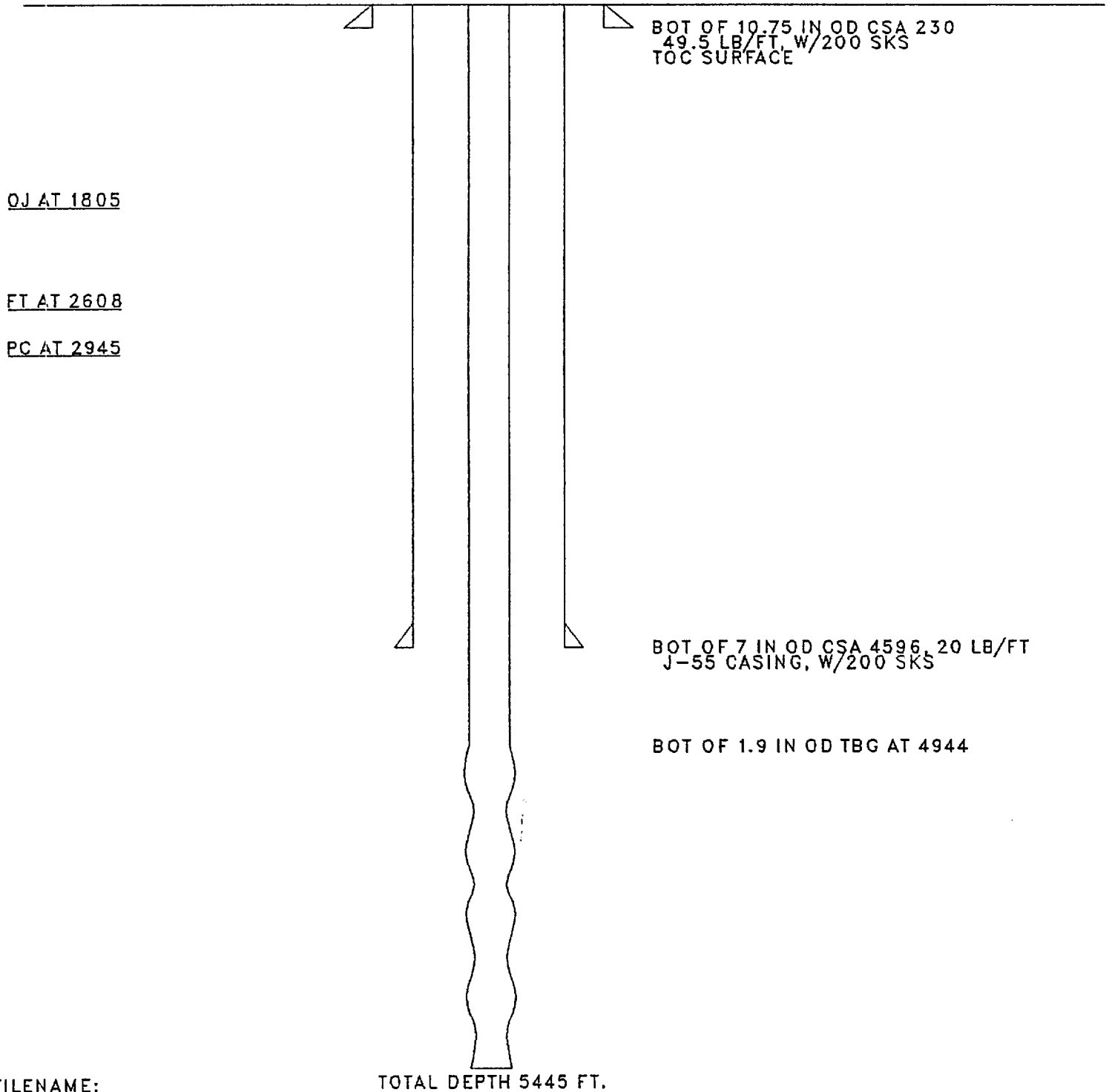

PXA Procedures
Gartner A #1

1. Check location for anchors. Install if necessary. Test anchors.
2. MIRUSU. Blow down well. Kill if necessary with fresh water.
3. POOH with 1.9" tbg and lay down. NDWH. NUBOP. RIH with 2 3/8" tbg and cement retainer, set retainer at 4550'. Test casing integrity to 500#.
4. Pump into open hole establishing rate and pressure. Squeeze open hole with 605.378 cuft cement. (100% excess). Pull out of retainer and spot a 50' cement plug on top. (17.048 cuft)
5. RIH with perf gun and shoot squeeze holes at 3000' and attempt to circulate to surface with 612.00. If unable to circulate, RIH with tbg and cement retainer, set retainer 50' above the squeeze holes and attempt to circulate to surface.
6. If unable to circulate to surface be sure the following formations are covered 100' inside and outside casing; Fruitland Coal @2608, and the Ojo Alamo @1805'. Perf at 280' and circulate to surface, displace cement inside casing to surface with 163.656 cuft cement.
7. NDBOP. Cut off casing and wellhead. Install PXA marker according to BLM or State requirements.
8. Turn over to John Schwartz for reclamation.
9. Rehabilitate location according to BLM or State requirements.
