PXA Procedures
Gartner A #5

1. Check location for anchors. Install if necessary. Test anchors.
2. MIRUSU. Blow down well. Kill if necessary with fresh water.
3. POOH with 2' tbg. NDWH. NUBOP. RIH with 2 3/8" workstring and cement retainer, set retainer at 4525'. Test casing integrity to 500#.
4. Pump into open hole establishing rate and pressure. Squeeze open hole with 655.632 cuft cement. (100% excess). Pull out of retainer and spot cement plug to 2825'. (563.55 cuft cement)
5. RIH with perf gun and shoot squeeze holes at 2658' and attempt to circulate to surface with 798.99 cuft cement. If unable to circulate, RIH with tbg and cement retainer, set retainer 50' above squeeze holes, and attempt to circulate to surface. Displace cement to surface with 881.127 cuft cement.
6. If unable to circulate to surface be sure the following formation are covered 100' inside and outside casing:

Fruitland Coal	2658'
Ojo Alamo	1800'
Nacimiento	562'
Surface plug	200'
7. NDBOP. Cut off casing and wellhead. Install PXA marker according to BLM or State requirements.
8. Turn over to John Schwartz for reclamation.
9. Rehabilitate location according to BLM or State requirements.
