On September 16, 1969, this well was plugged and abandoned as follows:

Ran tubing to total depth and spotted a 50 sack cement plug.

Perforated 4 holes below Ojo Alamo at 400'. Nippled up on 5 1/2" casing and pumped in 75 sacks of cement.

Pressured up to 400 psi and displaced last 5 bbls. through perfs. Left 5 1/2" casing full of cement.

Dug down about 5' around wellhead but found no surface casing. Filled hole with cement, removed wellhead and levelled location.
