On 4-16-65 set bridge plug at 5200', located hole in casing at 4146'. Set cement retainer at 4039', squeezed hole in casing w/100 sacks Class "C" cement, 2% calcium chloride. Held 600#.

4-17-65 drilled out cement and bridge plug.

4-18-65 cleaned out w/gas, ran 224 joints 2 3/8", 4.7#, J-55 tubing (6797.27') landed at 6807.27' w/Baker Model "P" packer set on bottom of tubing.

Instructions
