Bridge plug set at 7190 perforated 7088 to 7122 w/2 jets and 2 bullets per ft. frac w/71,000 gals water, 40,000# sand. Breakdown 1900#, treated at 2500# 19-40 BPM Bridge plug set 7062 perforated 7011-21 2 jets and 2 bullets per ft. frac w/32,400 gals. water & 12,400# sand breakdown 2200#, treated w/2750# 12-41 BPM cleaned out to PHED 7266, ran 2" tubing landed 7206' and well unloaded without swab. Well shut-in for test.
