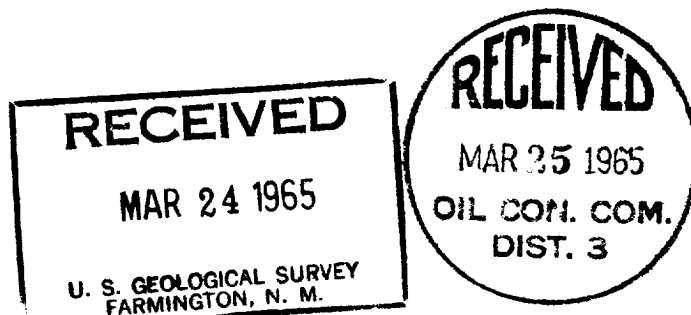

Rig up Workover March 6, 1965.
Pulled 1" tubing. Clean well out. Ran 82 jts of 3-1/2" casing at 1658'. Cement with 125 sacks of Class "C" cement 6% gel mixed 2% calcium chloride - 1/4 lb. floccula mixed. Perforated at 1664 to 1674. 40 shots. Fyne with 10,000 20-40 sand and 10,000 10-20 sand FR-5 6% per 1000. 20,370 gallons of water. Ran 75 joints of 1" tubing set at 1670. Rig down March 11, 1965.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
