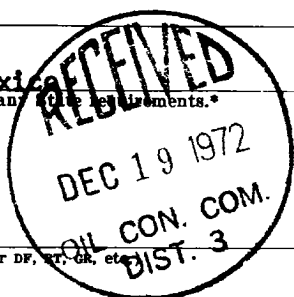

- 12-7-72 Moved work over unit on location, rigged up, install Blowout Preventor, kill well, pull tubing, reran tubing with bridge plug set bridge plug at 6700 ft.
- 12-8-72 Circulated hole clean, pull tubing out of hole, reran tubing with packer, test casing for holes, found bottom hole at 4984 top hole @ 4127.
- 12-9-72 Squeezed with 300 sks cement, squeeze pressure up to 850 lbs. on displacement of cement held 2 hours released packer, pull tubing reran tubing with 3 7/8 bit, W.O.C.
- 12-10-72 Found top of cement at 3879 drill solid cement to 4517' pressure up every 100' to 2000 lbs. holding ok.
- 12/11/72 Drill solid cement to 4987, pressure up every 100 ft. to 2000 lbs. OK, drill out cast iron bridge plug at 6700 ft. clean out to T.D. 6997, pull tubing with bit, reran tubing, remove blowout preventor, land tubing.
- 12-12-72 Swab well 10 hrs, well kicked off blowing fair, making 1" stream of water, gas to small to measure. Released rig @ 6:00 P.M.
