DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde section, and to shoot the entire Mesaverde with approximately two quarts of S.W.G. per foot. The pay section will be drilled with gas circulation.

Casing Program as Follows:

9-5/8" at 300' with cement to surface.

7 " at 4790' with 300 sacks cement.

$E\frac{1}{2}$ of Section 25 is dedicated to this well.
