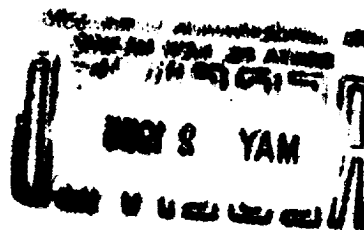
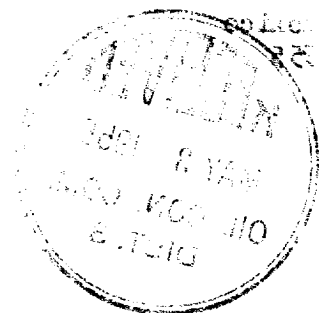

Gentlemen:

In compliance with your letter of March 30, 1955, and memorandum and orders relative to non-standard gas proration units in the Northwestern Gas Pools, the B.M.N.S. Company submits the following information:

1. The Copp #1 well is located 1980 feet South of the North line and 330 feet East of the West line of Section 29, Township 30 North, Range 12 West, N.M.P.M., Unit "E", in the Fulcher-Kutz Pictured Cliffs Gas Pool.
2. The non-standard unit comprises 40 acres and said well was completed September 22, 1946, at which time present spacing requirements were not in effect. This well is connected to the Southern Union Gas Company line.
3. The proposed non-standard unit lies wholly within a single governmental section.
4. The entire unit may reasonably be presumed to be productive of gas.
5. A copy of this letter, advising of the intent to form this non-standard unit, is being sent to all offset operators by registered mail.
6. Plans showing location of well and offset operators are attached.
