

DETAILS OF WORK

We propose to drill the above well to approximately 5100 feet. Rotary tools will be used to total depth. Casing will be set on top of Cliffhouse. Mesa Verde formation will be drilled with gas and shot with SNG.

The following casing program is proposed:

9-5/8"	250	225	175% of calculated amount to circulate
7"	4200	200	100% of calculated amount to fill 1260' above shoe.
