Drilled bridge plug at 4590' and spotted a 100 sacks cement plug over perforations 4418' to 5142'.

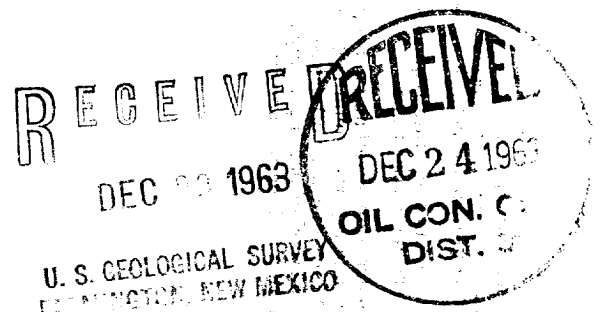
Shot off 7' casing at 1533' and pulled casing.

Ran tubing and spotted 50 sack cement plug over casing stub.

Set a 10 sack cement plug at surface and installed a 4" x 4' dry hole marker.

Cleaned and levelled location.

Abandonment was completed 12-18-63.
