- 6-5-85 MOL & RU. Attempted to pull tbg. Tubing stuck. Cut off tbg @ 4412' & recovered 122 jts. Ran 7" cmt retainer, set at 4238'. Squeezed open hole section w/100 sks class B, 4% gel, 1/4 cu ft of Gilsonite/sk followed by 50 sks class B, 2% CaCl₂ and 1% sand. 240' cu ft. Job completed at 12:45 PM.
- 6-6-85 Press tested casing 1000 psi. Held ok. Perf'd 1 squeeze hole at 1640'. Ran 7" cmt retainer, set @ 1553'. Squeeze cmt'd Ojo Alamo w/150 sks class B, 2% CaCl₂ (177 cu ft). WOC 12 hours.
- 6-8-85 CO open hole section 4375'. Drilled side track hole.
- 6-10-85 Drilled into old open hole. TOOH. Ran 7" cmt retainer set at 4250'. Squeezed open hole section w/100 sks class B, 4% gel, 1/4 cu ft Gilsonite followed by 50 sks class B, 2% CaCl₂, 10% sand. WOC 12 hours.
- 6-11-85 CO to 4364'. Side tracked hole at 4364 and drilled 22'. Ran reamer and opened hole and continued drilling operations.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
