Perforated Cliffhouse section with Triple Frac Notch Cutter at 3541. Landed tubing at 3573, and swabbed well in. Casing and tubing on vacuum. Shut well in for pressure test. After 24 hours shut in casing had slight blow. Tubing on slight vacuum. Reperforated casing with 4 shots per foot 3542-3544. Reran tubing and swabbed well in. Cleaned up well and tested.

Potential test May 8, 1962, Flowed 1878 MCF per day, through 3/4" choke after 3 hours flow. Absolute open flow potential 1985 MCF per day. Shut in casing pressure after 7 days shut in 1226 psig.

Completed as shut in Flora Vista Mesaverde Field Well May 4, 1962.
