The log log paper used for plotting the back pressure curve shall be of at least three inch cycles.

- Q \equiv Actual rate of flow at end of flow period at W. H. working pressure (P_W). MCF/da. @ 15.025 psia and 60° F.
- P_c= 72 hour wellhead shut-in casing (or tubing) pressure whichever is greater. psia
- Pw Static wellhead working pressure as determined at the end of flow period. (Casing if flowing thru tubing, tubing if flowing thru casing.) psia
- Pt Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.) psia
- Pf Meter pressure, psia.
- hw Differential meter pressure, inches water.
- Fg Gravity correction factor.
- F_{t} Flowing temperature correction factor.
- F_{DV} Supercompressability factor.
- n I Slope of back pressure curve.
