Rig up and set 7" drillable packer in 7" casing and squeeze open hole with 350 sx Class "A" cement, 12 1/2% gilsonite, and 100 sx "A" 15% sand cement. Drill with 3" knuckle joint to Dakota zone to approximately 7155'. Log and run 4 1/2" casing, cement in two stages. First stage T.D. to 500' above top of Mesaverde. Second stage circulate cement from 500' above Mesaverde to surface. Perforate and free Dakota and Mesaverde. Set Model "D" packer above Dakota and complete as dual. Conduct deliverability test and packer leakage test.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: If the well is to be drilled only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the road, well, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

Items 15 and 18: If well is to be, or has been directionally drilled, give distances for subsurface location of hole in any present or objective production zone.

Item 22: Consult applicable Federal or State regulations, or appropriate officials, concerning approval of the proposal before operations are started.
