DETAILS OF WORK

The above well was converted to a water injection well on 3-7-62 as follows:

1. Hot oiled casing annulus and pumped backload.
2. Moved in and rigged up pulling unit and pulled rods and pump.
3. Ran casing scraper on tubing and circulated hole clean with oil.
4. Displaced oil with treated water and pulled tubing.
5. Ran 2-3/8" tubing with Baker Model B packer set at 3816'.
6. Hooked up to injection system and started injecting water down tubing and annulus into lower and upper Gallup zones 3-17-62.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
