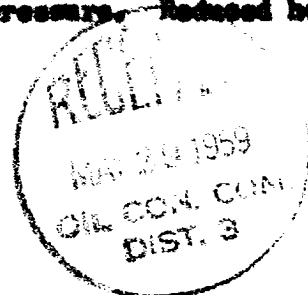

DETAILS OF WORK

J. C. Aidlin "C" Well No. 1 was spudded on May 12, 1959 and on May 13, 1959, 8-5/8" casing was landed at 215' with 160 sacks of cement containing 2% calcium chloride. After waiting on cement, casing and water shut off were tested with 400 pounds pressure for thirty minutes which held with no drop in pressure. Reduced hole to 7-7/8" at 215' and resumed drilling operations.
