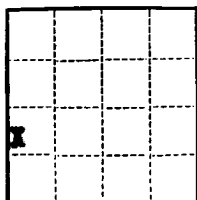

DETAILS OF WORK

J. J. Lemmeri "A" Well No. 3. On June 5, 1959, 5-1/2" casing was landed at 3993' with 80 sacks 64 gal cement with 1-1/2 pound Tuf Plug per sack, followed by 50 sacks neat cement. Released rotary rig on June 5, 1959. Moved in completion on June 7, 1959 and tested casing with 3000 pounds pressure for fifteen minutes, which held with no drop in pressure.
