On 12-10-69: Ran fullbore packer and found bottom leak in casing at 1865' and top leak at 1500'. Set cement retainer at 1370' and squeezed leaks with 400 sacks cement. W. O. C. and drilled out cement, tested casing to 1000', O.K. Re-run tubing with production packer set at 4845'.
